- San Jose Water (John Tang)
 - Vice Mayor: People are concerned about water rate increases
 - Asked John Tang with San Jose Water to give brief overview
 - We can ask John to join a future meeting to discuss more details
 - JT: Water system is performing well in spite of pandemic, fires.
 - Spent \$1B on improvements in the last decade.
 - People want to know why water cost are rising
 - This can't be explained completely in 10 min discussion
 - Water costs rising across the industry due to infrastructure investments.
 - Try Googling US EPA, American Water Works Association and American Society of Civil Engineers
 - [Steve Ling: here are some links I found:
 - Water costs are rising across the US
 - Costs to fix aging infrastructure
 - Higher costs after storms due to climate change
 - Chart showing water cost vs inflation
 - Chart of rate increase by city (SJ is not the worst)
 - Residents protest bit rate increase by San Jose Water
 - Some of SJ will see 30% increase next 4 years
 - Cost of water quality requirements
 - Cost of cybersecurity and data privacy

- Recent merger with Connecticut Water
- SJW charges more that other local water providers
- Last year SJW forced to pay back overcharges]
- JT: There are risks to deferring maintenance. <u>Jackson, Mississippi</u> for example. It is important to understand what is driving these cost increases. Can provide more details if invited back for a longer discussion.
- Q (Bob L): I'm chair of the Environmental Resource Advisory Committee for Valley Water. How mach water does SJW get from Valley Water?
- A (JT): 90% from Valley Water (50% Sierra, 40% ground, rest surface) \$0.38 of rates go to Valley Water so Valley Water costs heavily impact SJW water cost.
- Q (Gary C): Water cost came up in a Neighborhood Commission a while ago. Curious if SJW, being a for-profit org, is properly maintaining infrastructure? What is the city doing to help manage water cost?
- A (JT): Every 3 years SJW reports operation and maintenance costs in a <u>General Rate Case</u> that is used by PUC to set water rates. SJW serves 80% of San Jose. The other utilities in SJ buy water directly from Valley Water.
- A (Vice Mayor): Nobody likes rate increases, especially in tough economic times. Let's plan a future session to go into more detail on water costs. City of San Jose does not control water costs.
- A (JT): CA PUC sets rates, takes a year, set every 3 years, 10,000 page are reviewed in detail. The public advocate office represents consumers.
- West San Jose Multimodal Transportation Improvement Plan (MTIP)
 - Speakers: Augustin Cuello (project manager), Natasha Opfer (engagement lead)
 - Vice Mayer: I wanted D1LG to hear this plan because it brings together what SJ has been working to accomplish over the past 6 years.
 - AC: Review goals and timeline for multi-modal transportation plans. Identify the best ideas, prioritize, align with climate goals. Similar to what Urban Village doing for land use.
 - Funded by NTC

- Goals: Health/safety, social equity, multi-modal mobility, robust economy
- Create great places to enjoy with friends family, to be active, and the way that we move through those places enjoyable
- Starting community engagement this month with open house, the meetings to focus on specific areas
- Comprehensive bike plan
- Stevens Creek pedestrian crossing
- New off ramp between 280 and Winchester
- Pavement programs
- Q (Carlin): What's happening with Innovation Zone?
- A (Vice Mayor): Working on gunshot detection in Cadillac, and Feed Our Frontline to fund food for first responders (active now). More in the queue.
- Q (Bob): Saratoga and El Paseo are on tier 3. Can we move to tier 2?
- A: May remove tiering system.
- Q (Bob): Is overpass between Valley Fair and Santana Row ever going to happen?
- A: Reviewing feasibility
- Q (Ken): I'm signed up for Emerging Mobility Action Plan Digital Workshop. Is that part of this?
- A: No, but what the find will feed into this plan.
- Q (Amy C): What about outlying communities without light rail?
- A: We plan to create a toolbox of options that can be used in cases like this.
- Vice Mayor: We can schedule follow up meeting. Can also join neighborhood Zoom meetings.
- O (Steve L): Question for Vice Mayor. Reports of large groups of bicyclists traveling through the neighborhood and taunting traffic making neighbors uncomfortable. Are you aware, and what can be done?
- A (Vice Mayer): Recently made aware. A few NextDoor postings. Not how often this occurs or was a one-time event. Don't know who is organizing.
- Q (Steve): Neighbors reported to SJPD, so they should have details on when and where.

 - SB6/SB9/SB10/SB478 at the state level
 - How much of SJ is single famly?
 - o 94% by area
 - o 78% by parcels
 - o 61% by population
 - Review SJ proposal (see slides)
 - o Recently extended to be city-wide
 - Silicon Valley at Home (15 minutes)
 - Mathew Reed Policy manager (part of coalition San Jose Neighborhoods for All)
 - o 94% by area is single-family (unusually large)
 - 50% of pop lives on 94% of the land
 - Oakland 60%, 50%
 - o Need 63,000 new homes RENA?
 - o Problem is zoning
 - o Urban Village original plan for transition zone
 - o New plan is some increase across entire city

- o Gap in cost of homes
- o Losing young families, can't afford
- o People are forced to commute (160K daily)
- Nikita Sinha (District 1 resident, member Neighborhoods For All coalition
 - o Not new idea, multi-family 1500 in city, 600 in D1
- Mathew
 - o Clearly this is a controversial issue
 - o No policy in place yet
 - o Currently exploring options
- Nikita
 - o Current housing market is broken
- Mathew
 - o Go to SJNeighborhoodsForAll.com
- Families & Homes SJ (15 minutes)
 - Pierluigi Oliverio
 - (See slides)
 - Euphemism for eliminating SFH
 - 53.4% of housing in SJ is SFH
 - Oregon (speculation fees)
 - Minneapolis (in the courts, supreme court rules against)
 - Sacramento (part of a long list of proposals)
 - Argument: SFH block everyone
 - Look at who is driving this plan (don't live in SJ)
 - SJ general plan includes 300K units in transition areas
 - History: SJ has been leader in building housing
 - SJ tax revenue poor mostly housing impact services
 - SJ gave up commercial land for housing
 - Low income housing reduces taxes more
 - Developers pay fees for inclusionary housing
 - 70% of SJ residents work outside
 - General plan increasing density everywhere
 - With no community involvement! (by right)
 - State says can't regulate cars
 - We have ADUs now (market rate)
 - Picture next to multi-family
 - "Near transit" include most of the city (bus lines)
 - Also considering commercial conversion to MFH

- Support: Smart growth plan, ADUs, Urban Village
- Need to work with nearby cities
- No example of success right now?

- Q Steve: Pictures don't show all the cars typical for multi-family homes. What is problem trying to solve? More housing units or more affordable? If affordability what about incentives. A: Pictures just pulled from Google maps. SJ needs higher density housing to make housing more accessible. There are no incentives that can close a gap this large. Q: Didn't really answer the question.
- Q Gary Smith: Question about other, Montgomery, also in progress.
- Q: Amy: What about lot sizes? 11-12K lots, most were multifamily or multi-generation, living in 6K lot and hard to imagine how this will fit. A (PL) No detail yet on lot size? A: Mathew there are existing standards for multi-family homes
- Q (Bill Rankin): Against OH. What about parking? Are the pictures really represent what would happen with this. A (MR) parking is a concern, will happen slowly, will be able to assess. We think the parking impact will be less. Q: City can't regulate parking.
- Nakita: this needs to be tied into
- Vice Mayor: still trying to understand what this means, not a firm position yet
- PO: Did the city go too far to make this by right? VMJ: can't tell yet.
- Park fee: Are ADUs subject to this?
- Pat H: OH does not appear to be fair to long-term homeowners. How will be compensated? Also, there are already example where existing multi-family homes caused parking issues (permits). A: (MR) Don't expect Pat's street to be taken over with multi-family. City has parking requirements. 40% front lot coverage. Expect the impact to be gradual
- Q: Bill) why do this if impact will be so limited?
- Roma: How did task force. Bob was on, and Bill.
